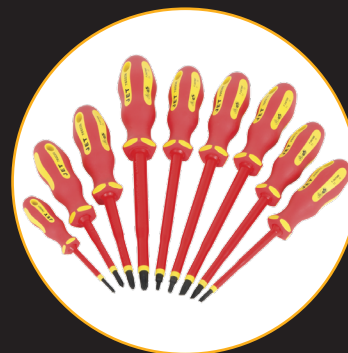

UL Certified is the gold standard where the whole garment is tested. UL Certified Components should also be reliable and safe. Of note, we are a stocking distributor, which means we have no minimum purchases and no need to enter into a contractual relationship. You can order what you need when you need it, and won't need to guess what sizes you may need for future employees or carry product that becomes unnecessary based on changing circumstances.

ASTM F1506 Certified by UL:

ASTM F1506, 2010A Standard Performance Specification for Flame Resistant and Arc Rated Textile Materials for Wearing Apparel for Use by Electrical Workers Exposed to Momentary Electric Arc and Related Thermal Hazards requires a sample of flame-resistant fabric to self-extinguish with a less than 2 second after flame and a less than 6-inch char length. The FR fabric must also pass these requirements after 25 washes/dry cleaning. Rasco FR garments are certified by Underwriters Laboratories to meet the requirements of ASTM F1506, 2010A.

NFPA 2112-19 Certified by UL:

Rasco FR offers flame resistant protective garments that are certified by Underwriters Laboratories to meet the requirements of NFPA 2112 Standard on Flame Resistant Garments for protection of Industrial \Personnel Against Flash Fire, 2012 Edition. UL has certified that Rasco FR garments are compliant with NFPA 2112 after 100 industrial washes.

CATEGORY 2 / HIGH RISK CATEGORY 2 – CAT2/HRC2:

HRC 2 Arc-rated FR garments with a required minimum ATPC of 8 cal/cm2 as determined by ASTM F1959.

CATEGORY 3 / HIGH RISK CATEGORY 3 – CAT3/HRC3:

HRC 3 Arc-rated FR garments with a required minimum ATPV of 25 cal/cm2 as determined by ASTM F1959.

CATEGORY 4 / HIGH RISK CATEGORY 4 – CAT4/HRC4:

HRC 4 Arc-rated FR garments with a required minimum ATPV of 40 cal/cm2 as determined by ASTM F1959.

ASTM F1959:

Method used for the determination of the arc rating of a material.

OSHA 1910.269(l)(6)(iii):

Covers the operation and maintenance of electric power generation, control, transformation, transmission and distribution lines and equipment. It states that employers shall ensure that each employee who is exposed to the hazards of flame or electric arc does not wear clothing that, when exposed to flames or electric arcs, could increase the extent of the injury that would be sustained by the employee. Rasco FR garments are compliant with OSHA 1910.269(l)(6)(iii).

CSA Z462:

This standard addresses electrical safety requirements for Canada. The US standard is NFPA 70E which aligns with CSA Z462

NFPA 70E:

Requires employees to wear flame resistant clothing with an ATPV, or cal rating, equal to or greater than the determined arc hazard. Rasco FR garments are marked with an ATPV rating so that they can be worn to meet NFPA 70E standards.

CGSB 155.20:

Meets minimum requirements for protection against hydrocarbon flash fire. Clothing meeting this standard provides a degree of protection reducing the severity of injury in the event of a hydrocarbon flash fire. Unless defined, garments under this standard are rated for 50 home washings.

ATPV:

Arc Thermal Performance Value. An ATPV is the incident energy on a material or system that results in a 50% probability to cause the onset of a second-degree burn. This value is expressed as a single number in calories/cm2. Ratings are based upon the total weight of the fabric.

What is an ARC FLASH?

An arc flash occurs when an electric current passes through air between ungrounded and grounded conductors, causing temperatures to reach up to 35,000° F. Exposure to these extreme temperatures burns the skin directly and also causes ignition of clothing, which worsens the injury. The majority of hospital admissions due to electrical accidents are from arc flash burns, not from electric shock.

Please Note:

Do not wear untreated cotton. An Arc Flash may ignite any cotton worn, especially against the skin. All tests are performed under laboratory conditions. The garments worn should be clean and in good repair for maximum protection.
